Thus, item 6. c. from the "Proposed papers to be filed with TSHL Archives" has been sent electronically. The paper copies of those 8 returns are ready to be placed in the mail and they will be mailed to you later today.

Regarding item 2 (Advisory Council Roster), I do not have knowledge of an advisory council after 2015. Attached are TSHL Advisory Committee Meeting Minutes for January 8, 2015. I do not have a separate roster; the first paragraph lists who the participants at the January 8, 2015, meeting were. These minutes will also be sent by mail today. It was expected that a new advisory council would begin in 2016, but I do not have any record that that occurred. This expectation was mentioned in the attached email of November 5, 2015. I have communicated with two past TSHLF leaders and neither had any further information about the advisory council beyond what I am sending with this present email.

Regarding item 7., Conflict of Interest Documents, I did not regularly receive those and thus do not have but a few. My understanding is that Jennifer plans to institute *annual* signing of a form.

Regarding items 6. a. and b., Jennifer plans to see what the office of the former treasurer may be able to provide. Regarding item 6. d., it is my understanding that there has not been an independent financial review since November 5, 2015 (when the "Proposed papers to be filed with TSHL Archives" – attached – appears to have been created).

I will see what I can locate regarding item 5.

Thank you for the update that you provided in your email of Friday (below). I am glad to have been able to send you, previous to this email, the items which you have added. Thank you very much for having added those.
