Dear Brother Colson:-

Mr. Larimore has been sick in bed two weeks; hence he has requested me to write you for him.

It is not necessary to send us the papers you mention; but if you will kindly send us a list of them, I'll write the publishers have the address changed.

We expected to pass through Gainesville to-morrow and have a few minutes stop; but have decided to make the trip from Tampa to Jacksonville at night, as Mr. Larimore is not yet able to sit up. We expect now to leave Tampa at 9 o'clock to-morrow night, remain in Jacksonville Monday, then take a sleeper to Nashville, via Montgomery. I'm greatly disappointed that we cannot pass Gainesville in daytime.

We have nothing encouraging to write relative to the school so far; but we have been in correspondence with Brother Isaac Tackett several months. expect to have a conference with him in a few weeks, and shall certainly not turn that \$40,000 down.

We expected to pick up Mr.Larimore's trunk as we passed through Gainesville; but shall have to have it sent home by freight, I presume. If I could be sure it would reach Jacksonville before we leave there, if sent by express,I'd ask you to send it that way;but the time is too short for that. We leave Jacksonville Monday at 8:15 p.m. Will be at the Seminole Hotel during the day,I think. I'll write Sister Bowers about the trunk.
