Recent changes to the franchise tax law allow a corporation to take a temporary credit against its franchise tax due on net taxable earned surplus, provided the corporation preserves its right to take the credit by March 2, 1992. NO EXTENSION CAN BE GRANTED.

The credit is for timing differences that exist at the corporation's normal accounting year end in 1991. These differences represent the excess of the basis used for financial accounting purposes over the basis used for federal income tax purposes of qualifying assets or liabilities that at some future date will reverse.

Once a corporation has preserved its right to take the temporary credit, the corporation may elect to take the credit on any franchise tax report due after January 1, 1992. The corporation must notify the Comptroller of this election on or before the original due date of the first report on which the credit will be taken. The election may be made on the extension form or the report form. A corporation may make only one election to take the credit. The credit is available for 20 consecutive privilege periods beginning with the first report due after January 1, 1992.

A corporation taking the credit must calculate and report its taxable capital using generally accepted accounting principles for each year until the credit is revoked, voluntarily or involuntarily, or until the credit expires. Once the corporation elects to take the credit, the use of federal income tax methods to compute taxable capital will automatically revoke the credit.

Beginning with the first report on which the corporation elects to take the temporary credit and for every report filed thereafter, the corporation must pay a tax of 0.2 percent of its net taxable capital, in addition to the tax on net taxable capital and the earned surplus surtax. The 0.2 percent rate will be prorated based on the number of months covered by the initial report. Failure to report and pay the additional tax on any report, even if the temporary credit cannot be used or is not advantageous, will result in the automatic revocation of the credit for that report and for future reports. Once the credit has been revoked, it is no longer available.

The credit is calculated by multiplying the amount of timing differences by the earned surplus apportionment factor (Item 18) on the 1992 franchise tax report. The product is then multiplied by 5 percent (per privilege period) and by the earned surplus tax rate in effect for the year of the credit calculation.

To preserve the corporation's right to take the temporary credit, you must check the box in Item 1 below, enter the amount of timing differences in Item 2 and sign and return this letter to the Comptroller's office postmarked on or before March 2, 1992.






