Suggested activities to simplify books and balance cash assets and liabilities:

- 1. Request a check from the TSHL Foundation for 2007 expenses in the amount of \$10,000, as per budget. Note: Unless the TSHL suddenly gets very active this amount may not be required, but would provide an on-going cushion.
- 2. Write a check to the TSHL Foundation in the amount of \$6,305.85 to dissolve liabilities for 2006 Orientation rebates.
- 3. Receive a check from the TSHL Foundation in the amount of \$2,750.00---\$366.75 for grant expenses (grant account), and \$2,383.89(Directory account)

Note: The TSHL has virtually no financial resources outside of those held by the TSHL Foundation bank and yet we are committed to pay all of our expenses (on time), thus it may be necessary for the Comptroller to utilize "assets" and "liabilities" accounts. We need to find ways to establish a separate financial and legal identity for the TSHL in order to gain control and accurate accountability for TSHL finances and activities. Otherwise, as reported by former Comptroller, Barbara Effenberger, "so we make approximate reports and the funds are so co-mingled it makes budget control and reporting very difficult."

I am suggesting that the Foundation support our effort to become legally and financially independent as it would free them from the day-to-day operations of the TSHL and allow concentration on raising funds for the corpus and management of our financial assets. A model for TSHL independence is the Texas Retired Teacher's Association (TRTA) which has a separate Foundation and they have their own legal and financial identity for operating the organization.

Finally, as an alternative or temporary solution, I am proposing to the TSHL Foundation Board and the TSHL Finance and **Executive Committee that they consider the possibility of** appointing the TSHL Comptroller as a financial agent for the TSHL Foundation. A separate Foundation account would be established which will provide exclusively for TSHL financial operations as per established budget. While this may have some limitations and concerns relating to non-profit (501-C3) lobbying limitations etc., it is not without precident as the Foundation now hires a private accounting firm as its financial agent as well as AG Edwards. This would place all of the TSHL operations under one account and separate from the basic Foundation account. This is not a substitute for financial independence, but may provide for a way to achieve desired accuracy, accountability and reliability of TSHL financial operations.
